

WEDDING OFFICIANT CONTRACT

This Agreement made between Jacob Jurado and _____ (*BRIDE*) and _____ (*GROOM*) (*known in this contract as "Couple"*) is for the purpose of retaining an officiant to perform a marriage and wedding ceremony on the Couple's behalf.

___ Jacob Jurado agrees to provide support and guidance during the planning stages of the wedding ceremony and through the final vows of the wedding ceremony itself.

___ Jacob Jurado agrees to perform the ceremony in a respectful and professional manner in accordance with the ceremony planned by the couple. Jacob Jurado will dress appropriately for the wedding and arrive early on the day of the ceremony. Jacob Jurado will sign the wedding license after the ceremony and mail it back to the county within 9 days after the wedding, unless the Couple is already married and does not need a license signed

___ In the unlikely event that the Jacob Jurado is unable to perform the ceremony for unforeseen circumstances (ie. death, accident, injury, etc.) Jacob Jurado will do his best to find a replacements and return all monies paid to him back to the Couple. If a decision is made not to use the services of the Jacob Jurado, the couple must inform Jacob Jurado, in writing (email, letter, or text) 21 days days prior to the wedding date in order to release the Couple from this contract. If the Couple fails to provide such notice, the Couple agrees to be responsible for the remainder of the balance owed the Jacob Jurado.

___ At least one day prior to the wedding (unless other agreements have been made) the Couple agrees to pay:

___ \$ _____ for Jacob Jurado's basic fee

___ \$ _____ for Jacob Jurado to attend the rehearsal (\$75 for Mon-Thur or \$150 for Fri-Sun)

___ \$ _____ for Jacob Jurado to issue them a confidential marriage license

___ If the ceremony does not begin within 60 minutes from the wedding start time listed above, the couple agrees to pay Jacob Jurado an additional \$99 at the beginning of every 60 minutes that follows until the ceremony has started.

___ The Couple and Jacob Jurado agree to act in good faith towards one another and to communicate openly and honestly during the length of this contract

IN WITNESS WHEREOF, the parties hereto agree to the terms and conditions as described above and have caused this Contract to be signed on the dates indicated below. This contract, once signed, is considered by all parties within to be legal and binding in accordance with the conditions set forth herein, and shall abide by the agreed upon terms.
